
Background

- Work closely with Medicaid for federal funding match
- Refocused efforts toward health equity, rural health, and telehealth in 2021

Colorado's 2021 Health IT Roadmap






- 1. Coloradans, providers, payers, community partners, state, local, and Tribal agencies share data and have **equitable access** to needed health and social information.








Social Health Information Exchange

Goals:

Rural Connectivity

- 84 of 84 total rural safety-net facilities connected to Health Information Exchange
- Sustainability funding in partnership with Medicaid
- **Pilots** with unique digital solutions
- Success stories and partnerships

Focus for Continued Efforts:

 Independent rural health practices → where most rural patients and visitors receive care

- Internet use and cybersecurity related questions added to 2023 Colorado Health Access Survey (CHAS)
- Data Gathering to Fuel Equity
 - Demographic data baseline and technical assistance on improving both data and clinic practices and policies
- Dollars to Digitize
 - Technology Upgrades for Home and Community Based Service Providers and Behavioral Health Providers
